C&N reserve the right to substitute 77% material for any 67% material lens due to material manufacturer's batch / swell factor variations on sizes outside of the optimal 67% material range.

90-Day Manufacturing Warranty

All soft lenses come with a 90-day manufacturing warranty from date of despatch. Notify C&N immediately of any manufacturing faults that occur within the 90-day warranty period. Suspected faulty lenses are to be returned to C&N for analysis, stating account number, C&N order number and the suspected fault, and use secure recorded/tracked mail. C&N cannot be held responsible for lenses that are lost or damaged in transit en route to C&N. If a manufacturing fault is found a replacement lens will be urgently manufactured and despatched, free of charge. Lenses that are found not to have a manufacturing fault will be returned back to the customer after analysis and notification, whereupon a new chargeable lens may be requested. Alternatively, the lens will remain at C&N and a credit issued if applicable. Lenses with suspected errors are processed in the same manner as a suspected faulty lens.

Exchanges

Where applicable a lens may be exchanged within 90 days of the original order despatch date. Return the lens to C&N with a covering letter stating account number, C&N order number and the change in parameters that are required, and use secure recorded/tracked mail. C&N cannot be held responsible for lenses that are lost or damaged in transit en route to C&N. Discounted lenses are exchanged at the discretion of C&N. Carriage will be charged for all exchanges.

Trial Set

A trial set is a series of lenses varying in colour, colour density, pattern or design, used to establish the correct colour match. Trial Sets are issued at the discretion of C&N. All trial sets are chargeable.

Nissel Custom Hand Painted Lenses

Up to two free opaque iris fitting lenses may be requested, with a change in parameters to each lens, to establish the correct fit. Fitting lenses do not have to be returned to C&N. Please be aware that C&N does not offer an exchange or credit facility on this lens type.
